Executive Summary
<p>The Courtyard SLT and governors made an executive decision to allocate Additional Funding received by the school to a range of educational and social development areas to best benefit the pupils who were eligible for Free School Meals.</p> <p>The aim of the strategic allocation of all additional funding (Pupil Premium and Recovery Premium) is to support the development and progress of all pupils whilst reducing the gap between the achievements of disadvantaged pupils and their peers. It is recognised that pupils with ASC and a complexity of other needs, have significant difficulty in accessing the curriculum and making progress. Any needs regarding social, emotional and mental health need to be acknowledged and supported in order for the young person to access their learning and achieve their potential.</p> <p>The Courtyard SLT and governors allocate a significant percentage of Pupil Premium and Recovery Premium funding to CAMHS, Speech and Language and Counselling support within the school. Through a range of interventions, staff training and team teaching, all external services can support the development of the health and wellbeing of all pupils. The progress achieved by FSM pupils can be measured against their Appendix A targets.</p>

School-led tutoring funding will be primarily directed to those pupils eligible for Pupil Premium funding (14 pupils). The funding will enable students to access a minimum of 15 hours of tutoring during the 2022-2023 academic year. However, we have determined that non-PP pupils would benefit from direct tutoring and that pupils would benefit from 19 hours of tutoring (from Jan to date of final exam). Additional funds from the school's Recovery Premium will be allocated to this additional spend.

Last year (2021-2022): 79% of PP pupils made expected or more than expected progress compared to 83% of non-PP pupils in English. 75% of PP pupils made expected or more than expected progress compared to 88% of non-PP pupils in Maths.
